## **Terms and Conditions**

1.	A+ Canine Performance, LLC (hereon known as "The Company") cannot make any guarantees regarding
	the outcome of any training/counseling program. The owner assumes full and complete responsibility
	for the dog's behavior during and after the training/consulting program

- 2. The trainer is responsible for training the dog(s) for initial response on all commands listed on page 1 of this agreement. The trainer is responsible for training the owner to train the dog(s) on all commands listed on page one of this agreement. The owner understands that they are being trained to train their dog(s) and that without 100 percent cooperation, as well as consistent reinforcement the dog will not get trained. The owner is ultimately responsible for the dog's outcome. X
- 3. CANCELLATIONS: The owner/agent of the dog(s) may postpone any of the lessons provided 24 hour notice is given to "The Company". "The Company" is only obligated to give three (3) free make-up lessons due to owner/agent postponements. After third postponement, each additional owner/agent postponement will count as one of the remaining lessons owed to the owner/agent. Additional makeup lessons can be purchased at \$75 per lesson. The owner/agent understands and agrees that failure to give the company twenty-four hour notice of a lesson cancellation will result in the company counting said failure as a completed lesson.
- 4. TERMINATION OF TRAINING: The owner/agent of the dog(s) may have the animal withdrawn from training at any time, however, once training has begun, <u>all fees are non-refundable.</u>
- 5. LIABILITY: I, X\_\_\_\_\_\_ as the legal owner/agent of the above mentioned pet(s), having carefully read and fully understanding this agreement, do hereby waive and release "The Company" and Thomas Dixon (Trainer) from any and all claims due to damage the pet may to any family members or any third parties during or after training.
- 6. MISCELLANEOUS: The owner/agent will be responsible for purchasing all necessary equipment that the trainer recommends for training the dog(s)
- 7. In the event that "The Company" deems it necessary to employ legal counsel to protect its rights under this agreement, the owner/agent of the dog(s) agrees to pay all expenses incurred by "The Company" to enforce its rights under this agreement including, but not limited to, costs and reasonable attorney's fees.
- 8. This training agreement represents the full and only agreement between the parties. The terms and conditions set forth in this agreement cannot be modified or changed in any way. Any alterations or addendums to this agreement will not be valid or binding, nor will they affect the validity of any non-altered portions of this agreement unless signed by both parties. I have read, fully understand and agree to the above contract terms.
